- 1. Dr. ASHOK PANKAJ (Ph.D., LL.B) is Professor and former Director of Council for Social Development, New Delhi. He holds 28 years of teaching and research experiences; ten years of teaching on regular basis, and eighteen years of field based research on the socio-economic issues of development. He completed ten years as Professor on 23rd September 2023.
- 2. He has also served as Visiting Professor in Department of Sociology, Banaras Hindu University, Varanasi (13-25 November 2019), and visiting fellow (Professor) under UGC SAP programme in Department of Sociology, Maharshi Dayanand University, Rohtak, (Haryana) from 15-30 March 2015.
- 3. He has published seven books, five in English from international publishers, viz. Cambridge University Press, Sage Publication, Routledge, Springer and two in Hindi from Lokbharati Prakashan, Prayagraj. He has contributed more than 100 articles/chapters/reviews (31 research articles in reputed/peer-reviewed Journals, 18 chapters in edited books, and more than 53 book reviews, mostly in highly reputed journals).
