Have been involved with teaching activities at TERI School of Advanced Studies since 2010 as an adjunct/guest faculty and taught the following courses.

Course Title: Trade, Development and Environment (4 credits)

For the Programme M. Sc in Economics (Specialisation Environment and Resource Economics) of TERI School of Advanced Studies

The initial part of the course presents the evolution of theoretical models which demonstrate that there are gains from international trade. The course also delves into empirical studies that have been carried out to validate these models. While trade may improve productivity and incomes of nations, the distribution of the gains from trade may not be uniform across nations and within a nation. Further, trade may accelerate environmental degradation and climate change, even though there are possibilities that trade can even improve environmental performance. In a globalized world, policies pertaining to trade, capital flows and environment in one part of the world could have adverse impact in other locations. Therefore, in a globalized world, the success of the goals of sustainable development depends heavily on long term multilateral policies and actions. Finally, the course explores the role of globalization in economic development in India.

Course Title: India and the World

For the Programme MA in Public Policy and Sustainable Development of TERI School of Advanced Studies

This course discusses the debates surrounding globalization, climate change and geo-political and security challenges from an Indian perspective. It provides an understanding of how international agreements and institutions have been shaping up due to political, technological and economic forces. The role of India as well as the shrinking policy space at the national level is also discussed. The discussions on how ethics and equity can be mainstreamed in international laws and global institutions form an important part of the course.

The course is divided in three modules: (i) Globalisation and National Priorities; (ii) Changing Geopolitics and Implications for India; and (iii) Climate Change - Politics, Vulnerability and Adaptation.

I have been in charge of the first module of the course for the last five years.
